Terms and Conditions

4. Contest Draw

- a. For all prizes, the draw to select the Contest winners ("**Draws**") will be conducted on a <u>monthly</u> basis during the Contest Period. The number and type of prizes to be awarded each month shall be determined at the sole discretion of Epson.
